# HOW TO COMPLETE THE APPLICATION FOR SUBSCRIPTION SHARE FORM

Please complete all relevant sections of the Registration Form using block letters.

**A** Enter the full name/s and title/s of all legal entities to be recorded as the registered holder/s. Refer to the name standards below for guidance on valid registration.

**Unless advised to the contrary, for joint holdings, the first named applicant is the person to whom correspondence will be addressed and who will have the right to vote on behalf of shareholders.**

**B** Enter the postal address for all communications with the Co-operative. Only one address should be recorded.

**C** Enter a telephone number and a contact person that the Co-operative can speak to if they have any queries regarding this application.

**D** In the case of an individual, enter your tax file number (TFN) or exemption number. For partnerships or joint applications TFN's must be supplied for ALL applicants.

The rules relating to TFN's provide that every investment which pays a dividend can have the investor's TFN for exemption recorded.

Collection of TFN's is authorised and strictly regulated by taxation laws and the Privacy Act. Declining to quote a TFN is not an offence and will not invalidate an application for shares. Failure to provide a TFN may result in tax being deducted from the unfranked portion of any dividends paid on shares issued upon the exercise of options at the highest marginal rate plus medicare levy.

## Correct Forms of Registrable Title

Only legal entities may be registered as holders of the shares. Registrations must be in the name/s of natural persons, or legal entities. Shares **cannot** be registered in the name of a partnership, trust, business or trading names or the name of your farm.

The name of a beneficiary or any other name for identification purposes may be included by way of <ACCOUNT TITLE> if completed exactly as described in the examples below.
